It must be signed by the principal and the athletic director/head coach. In case of a breach of contract without mutual consent, the school that canceled without mutual consent of the other may be penalized by the Executive Committee; penalty – maximum of one year suspension from the Association (See Article 6, Section 6.4.1.24).
