Recap of Day One at The LHSAA State Volleyball Tournament; Semifinal Schedule set for Friday

Lafayette, La. – A thrilling day of quarterfinal matches trimmed the competition from 40 teams down to just 20, setting the stage for Friday's semifinals. The remaining 20 teams, now closer to a championship, are set to face off in high-stakes semifinals that promises intense competition as they vie for a place in the final showdown.
